The deadline to submit the application is March 3, 2025.

- Must have 2.5 GPA in core courses of Reading, Language Arts, Math, Science, and Social Studies.
- When the number of qualified student applicants exceeds the number of seats available, a random selection process will be utilized to admit eligible applicants.
- Failure to respond to our offer of acceptance by the specified time frame will be interpreted as declining the offer of acceptance.
 - **Accepted students not currently enrolled in Jane S. Roberts K8 must complete Parent Transfer form in order to attend. Please call school with any questions so we can assist.**
- Once a student is part of the Law Academy, their GPA cannot fall a 2.5 in their core classes. Students who do, will be placed on academic probation. Students unable to bring their GPA to 2.5 by the following quarter will be removed from the program.
- Students in the program who accumulate 10 or more absences or tardies will be placed on probation and will require an attendance contract.
- Students with five (5) or more detentions or three (3) or more days of indoor suspension or ANY outdoor suspension will be dismissed from the program.
- Transportation will need to be arranged by the parent/legal guardian.
